Prayer by Emmett Tyree

Minutes from 2015 accepted via email in October 2015. No further discussion.

Finance Report was presented by Laura Chumley (Sec/Treas). Motion to accept by Keowee. Second by Swamp Fox. Passed unanimously.

Tammy Carter presented ASA information.

Michael Grimsley presented S3DA information.

Information from Dayton Colie Webmaster presented.

Election Results presented by Laura Chumley. According to results--David Chumley, President, Brock Morris, NFAA Director, and Quiver Editor remains unfilled. Quiver Editor position will be evaluated as a position as we amend Constitution. According to Constitution, David Chumley must be approved by the board to serve a third term. Swamp Fox motioned that David Chumley serve a third term. Second by Keowee. Passed unanimously.

Angie Knight stepped down as Vice President. David Chumley had contacted Jamie Weatherford who was runner-up for VP in 2015 about filling the position. Jamie is willing to fill the position for the time remaining of term. Board had no other recommendations. Motion was made by Keowee to accept Jamie Weatherford as Vice President. Second by Sandune. Passed unanimously.

David Chumley presented to approve the payment of salary (\$200) to the secretary/treasurer as described in the Constitution. Motion was made by Sandune to pay the preset amount of \$200 to Laura Chumley, Secretary/Treasurer. Second by Swamp Fox. Passed Unanimously.

Discussion began to amend the Constitution. The changes discussed will be presented to clubs for verification. After clubs approve by vote, the amended Constitution will be presented to the SCAA membership for approval. The approved Constitution will then be sent to NFAA for approval.

The following are the more significant changes that were made.

- Dissolve the executive role of Quiver Editor.
- Add Webmaster as an Executive Board Office.
- Add distributing NFAA patches and certificates to the NFAA Director position.
- Have NFAA director instead of secretary/treasurer send current membership list to clubs periodically or as needed.
- Have webmaster/vice president to keep the records for the year.
- Corrected procedures for tournament scheduling process.
- Add SCAA will collaborate with representatives from other state archery & bowhunting organizations benefit the archery program

Guidelines & Expectations for SCAA clubs will outlined.

Lunch Break

State Tournaments were scheduled.

Club/Regional tournaments were scheduled.

Upper Regional clubs decided to have all tournaments count toward regional. The highest 2 scores from each club will count to regional scores. (2 Keowee, 2 TAB, 2 Midlands for 6 scores)

Discussed new Club Team tournament scheduled for July 15 at Midlands. Specific rules and guidelines will be set and given out at later date.
